ORDER

WHEREAS the institution namely **Akal College of Physical Education, Gursagar Mastuana Sahib, Tehsil & District- Sangrur, Punjab** submitted an application for grant of recognition of **B.P.ED** course of One years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 25.04.2005.

2. AND WHEREAS the matter was considered by the NRC in its 100th meeting held on 30th - 31st January, 2006 wherein the Committee decided to process the application further as per the rules and regulations of NCTE.

3. AND WHEREAS, the original file of the institution, Visiting Team Report, video CD, other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time was placed before the Northern Regional Committee in its 104th meeting held on 15th - 17th July, 2006 wherein the Committee decided to issue a Letter of conditional recognition and ask the institution to (1) appoint duly selected staff with the requisite qualification as per NCTE Norms and Standards and inform the Regional Committee (2) Launch official website of the Institution.

4. AND WHEREAS, in compliance to the above decision of NRC mentioned in para 3 above, letter of conditional recognition as per provisions contained under NCTE Regulation, 2005 was issued to the institution on 27.07.2006. The conditions mentioned in the letter is as follows :-

- (1) Appoint duly selected staff with the requisite qualification as per NCTE Norms and Standards and inform the Regional Committee
- (2) Launch official website of the institution.

5. AND WHEREAS, in response to letter of conditional recognition dt. 27.07.2006, the institution submitted its reply in NRC Office on 09.06.2009 with the direction / advise to **make the compliance preferably within 21 days** from the date of issue of this letter.

6. AND WHEREAS, the matter was considered by the Northern Regional Committee in its 142nd meeting held on 14th - 16th June, 2009 wherein the Northern Regional Committee observed that :-

Deficiencies communicated to the institution in the Show Cause Notice has not been replied within stipulated period.

7. AND WHEREAS, the Committee decided (in its 142nd meeting held on 14th - 16th June, 2009) decided to refuse the recognition.

8. NOW THEREFORE grant of recognition to **Akal College of Physical Education, Gursagar Mastuana Sahib, Tehsil & District - Sangrur, Punjab** for the course in **B.P.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.

9. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
