Accordingly show cause notice was issued to the institution on 23.04.2009 as under:-

The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141st Meeting held on 22th May to 24th May, 2009 the committee decides to issue letter of Intent prior to recognition under clause 7(9) of regulation 2007 with the direction that the selection committee as well as the appointed faculty should be as per NCTE norms. - 5. AND WHEREAS the applicant institution has submitted reply on 11.06.2009 to Northern Regional Committee, NCTE in response to this office letter dated 29,05,2009.
