## ORDER

WHEREAS **DAV SR. PUBLIC SCHOOL, SECTOR-8, PANCHKULA-134109, HARYANA** has submitted application for recognition (**HR- 251**) of NTT course of two years (2) duration under section **14(1)** of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS In its **106<sup>th</sup> Meeting held on 11<sup>ST</sup> -12<sup>TH</sup> August, 2006** the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued letter of conditional recognition on 17.11.2006 and clarification letter on 02.11.2007.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE by 22.05.2009. The matter was placed in **141<sup>st</sup> meeting** which was held on **22<sup>nd</sup> to 24<sup>th</sup> May, 2009**, the original file of the Institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- **The list of Faculty selected by dully constituted selection committee as per NCTE Norms is not submitted.**

5 AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution.


