ORDER

WHEREAS **Modern College of Education, Vill- Ranwan, Po- Khanpur, Tehsil- Malerkotla, Sangrur-148023, Punjab** of recognition (**PB-338**) for **B.ED** course of One years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS In its **104th** Meeting held on **15th to 17th July 2006**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied and decided to issue letter of intent prior to recognition under 7(11)/7(9) of the regulations 2006/2007 respectively. The letter of intent prior to recognition was issued to the institution vide our letter dated **25.07.2006** and clarification issued on **07.10.2007**.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE by the stipulated period. The matter was placed in **142nd** Meeting held on **14th June 16th June 2009**, the original file of the institution, along with all the other related documents, affidavits, NCTE Act 1993, Rules/regulations of NCTE published from time to time, etc. were considered and the committee observed that:

- **Deficiencies communicated to the Institution in the Show cause notice has not been replied within stipulated period.**

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to **Modern College of Education, Vill- Ranwan, Po- Khanpur, Tehsil- Malerkotla, Sangrur-148023, Punjab** for the course in **B.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs 5.00 Lakhs bearing No. **DV937666** is returned herewith.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of the NCTE Act, 1993.
