**ORDER**

WHEREAS, **C.T. College of Education, Greater Kailash, Maqsudan Chowk, Jalandhar, Punjab** had applied for grant of recognition (**PB-518**) for **B.ED Add Intake** of **One** year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 126<sup>th</sup> Meeting held on 20<sup>th</sup> to 22<sup>nd</sup> February 2008, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the applicant institution issued conditional recognition to the applicant institution on 26.02.2008 and clarification was issued on 29.05.2009.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE by the stipulated time period. The matter was placed in 142<sup>nd</sup> Meeting held on 14<sup>th</sup> June 16<sup>th</sup> June 2009, the original file of the institution, along with all the other related documents, affidavits, NCTE Act 1993, Rules/ regulations of NCTE published from time to time, etc. were considered by the committee observed that:

- Deficiencies communicated to the Institution in the Show cause notice has not been replied within stipulated period.

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to **C.T. College of Education, Greater Kailash, Maqsudan Chowk, Jalandhar, Punjab** for the course in **B.ED Add Intake** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing No. 989024 is returned herewith.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
