REFUSAL ORDER

WHEREAS DEEN DAYAL COLLEGE, 4TH KM. STONE, BHOPA ROAD, SHANTI NAGAR, MUSTAFABAD, MUZAFFAR NAGAR-251801, UP. had applied for grant of recognition (UP-1845) for B.Ed. Additional intake one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 118th (second sitting) meeting held on 23th 25th June 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to Issue a letter of intent prior to recognition with direction to the institution to provide the following documents (i) Advertisement Notice (ii) Consolidated Staff list on the prescribed format duly approved by the affiliating body. (iii) Proceedings of the selection Committee alongwith a copy of the letter from the affiliating body nominating a member for the selection committee.(v) Individual Bio - data in respect of selected faculty. (vi) Affidavit on Rs. 10/- stamp paper on the prescribed format. Accordingly letter of intent prior to recognition was issued to the institution on 04.07,2007, and reminder dated 30.01.2009.
- AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.
- NOW THEREFORE grant recognition to DEEN DAYAL COLLEGE, 4TH KM. STONE, BHOPA ROAD, SHANTI NAGAR, MUSTAFABAD, MUZAFFAR NAGAR-251001 ,UP, for the course in M.ED course is hereby refused.
