REFUSAL ORDER

18 JUL 2009

WHEREAS Institute For Advance Studies, Khasra No. 932, Vill.-Rori, Tehsil-Modinagar, Distt.-Ghaziabad, UP. Had applied for grant of recognition (UP-2937) for B.ED. Course one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 132<sup>ND</sup> meeting held on 11<sup>th</sup> - 14<sup>th</sup> September 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, and committee decided 7(11) - subject to submission of affidavit on Rs. 100/- stamp paper about the staff. Accordingly letter was issued to the institution on. 30.09.2008.

4. AND WHEREAS the applicant institution has not submitted reply, The matter was placed in NRC in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> -24<sup>th</sup> may 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

→ The list of appointed faculty as per NCTE Norms has not been submitted till date.

5. NOW THEREFORE grant of recognition Institute for Advance Studies, Khasra No. 932, Vill.-Rori, Tehsil - Modinagar, Distt.-Ghaziabad, UP. for the course in B.ED. is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the Council in terms of section 18 of NCTE Act, 1993.
