REFUSAL ORDER

WHEREAS SWAMI VIVEKANAND COLLEGE MUSTAFABAD, PANCHENDA KALA BYE PASS ROAD, MUZAFFAR NAGAR, U.P. had applied for grant of recognition (UP-2654) for B.ED. Course One years(s) duration under section 14 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 136 meeting the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition with direction to the institution to provide the following documents (1) the institution shall make appointment of faculty /staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An affidavit on the prescribed format on Rs. 100 stamp paper from the management of the Institution is required to be submitted. (2) the institution shall launch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, classrooms, and other facilities /amenities), instructional facilities (laboratory, library etc.) and the particulars of their proposed teaching and non teaching staff etc. with photographs. The details of the website may be submitted. Accordingly letter of intent prior to recognition was issued to the institution on 13.4.2009.

4. AND WHEREAS the applicant institution has submitted reply dated 04.05.2009. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

4. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

5. NOW THEREFORE grant recognition to SWAMI VIVEKANAND COLLEGE MUSTAFABAD, PANCHENDA KALA BYE PASS ROAD, MUZAFFAR NAGAR, U.P. for the course in B.Ed. is hereby refused.

5. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
