- 3. AND WHEREAS in its 113 meeting the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 19.2.2007 to the applicant institution under provise to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution had not submitted any representation to Northern Regional Committee, NCTE. The institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC in its 140 meeting held on 25-26 April 2009 the regional committee observed that the reply has not been received within stipulated period. Hence the committee decided to refuse recognition and return FDRs if submitted.
- NOW THEREFORE grant of recognition to SHRI JI BABA INSTITUTE, SEMARI, CHHATA, NH-2, MATHURA, U.P. for the course in B.P.Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
- The Institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
