REFUSAL ORDER

WHEREAS NAVYUG MAHAVIDYALAYA, RATANPUR, BARI SAHIJAN, SULTANPUR, U.P. had applied for grant of recognition (UP - 2859) for M.P.Ed. course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its **132 (2ND) meeting** the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on **26.9.2008** to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.


4. AND WHEREAS the applicant institution had not submitted any representation to Northern Regional Committee, NCTE. The institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC in its 140th meeting held on 25-26 April 2009 the regional committee observed that the reply has not been received within stipulated period. Hence the committee decided to refuse recognition and return FDRs if submitted.

5. NOW THEREFORE grant of recognition to NAVYUG MAHAVIDYALAYA, RATANPUR, BARI SAHIJAN, SULTANPUR, U.P. for the course in M.P.Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.

7. The original FDR Rs. Five lacs no. 496510 dated 15.1.2008 and FDR Rs. Three lacs no. 496550 dated 10.03.2013 are return herewith.
