#### REFUSAL ORDER

WHEREAS INTERGATED SCHOOL OF EDGUATION, ADHYATMIC NAGAR, DELIH HAPUR BYE PASS, NH-24, NEAR DASNA RAILWAY CROSSING, GHAZIABAD, UP. Had applied for grant of recognition (UP-1781) for BTC. Course two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- 2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 104th meeting held on 15th 17th July 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant and committee decided to issue a letter of conditional recognition and ask the institution to (1) appoint duly selected staff with the requisite qualification as per NCTE norms and standards and inform the Regional Committee. Accordingly letter of intent prior to recognition was issued to the institution on 9.07.2006 and clarification 10.11.2008.
- 4. DAND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141" meeting held on 22<sup>nd</sup> -24<sup>th</sup> may 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of MCTE Published from time to time, etc. were considered and the committee observes that:
  - The list of appointed Faculty as per NCTF. Norms has not been submitted till date.
- 5. NOW THEREFORE grant of recognition INTERGATED SCHOOL OF EDCUATION, ADHYATMIC NAGAR, DELHI HAPUR BYE PASS, NH-24, NEAR DASNA RAILWAY CROSSING, GHAZIABAD, UP. for the course in BTC is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
