REFUSAL ORDER

WHEREAS APEX INSTITUTE OF MANAGEMENT STUDIES & RESEARCH, KHASRA NO. 1004/1, PRATAPUR BY PASS ROAD, VILLAGE- GHAT, PO- PANCHLI, MEERUT, UP. had applied for grant of recognition (UP-1776) for BTC Course two years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 105th meeting held on 28th 30th August 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution and committee decided to issue a letter of conditional recognition and ask the institution to (I) appoint duly selected staff with the requisite qualification as per NCTE norms and standards and inform the Regional Committee, (2) Launch official website of the institution. Accordingly letter of Intent prior to recognition was Issued to the institution on 11.8.2006.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.
- NOW THEREFORE grant recognition to APEX INSTITUTE OF MANAGEMENT STUDIES & RESEARCH, KHASRA NO. 1004/1, PRATAPUR BY PASS ROAD, VILLAGE-GHAT, PO- PANCHLI, MEERUT, UP. For the course in BTC is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
