#### REFUSAL ORDER

WHEREAS ARYA KANYA P.G. COLLEGE, SIPRI BAZAR, JHANSI-284003, UP. Had applied for grant of recognition (UP-2088) for B.ED. Course one years(s) duration under section 14(1) of the NCTE. Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 113th meeting held on 18th 19th January 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials famished by the applicant institution and committee decided that recognition be granted to the B.Ed. course of one year duration with an annual intake of 100 students subject to the condition of appointment of qualified staff through duly constituted selection committee as per norms of NCTE/State Govt./ Affiliating university given effect before the committeement of the course. Accordingly letter of intent prior to recognition was issued to the institution on. 24.01.2007.
- AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> -24<sup>th</sup> may 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:
  - The list of appointed faculty as per NCTE Norms has not been submitted till date.
- 3. NOW THEREFORE grant of recognition ARYA KANYA P.G. COLLEGE, SIPRI BAZAR, JHANSI-284003, UP, for the course in B.ED, is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the gouncil in terms of section 18 of NCTF. Act, 1993.
