WHEREAS, **Shivalik Hills College of Education, VPO- Manakpur Patti, Nangal Dam, Roper, Punjab** had applied for grant of recognition (**PB-399**) for **ETT Course** of Two year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its **127th** Meeting held on **27th to 29th March 2008**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the applicant institution issued conditional recognition to the applicant institution on **NII** and clarification was issued on **02.06.2009**.

4. AND WHEREAS the applicant institution has submitted its representation to Northern Regional Committee, NCTE by the stipulated time period. The matter was placed in **143rd** Meeting held on **27th to 29th June 2009**, the original file of the institution, along with all the other related documents, affidavits, NCTE Act 1993, Rules/ regulations of NCTE published from time to time, etc. were considered by the committee observed that:

- **The documents related to selection of Faculty are not submitted.**

5. AND WHEREAS the committee decides to refuse the recognition for **ETT**.

6. NOW THEREFORE grant of recognition to **Shivalik Hills College of Education, VPO- Manakpur Patti, Nangal Dam, Roper, Punjab** for the course in **ETT Course** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. **5.00 Lakhs** bearing No. **643163** is returned herewith.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
