REFUSAL ORDER

WHEREAS Y.S.L. COLLEGE OF EDUCATION, SARDHANA ROAD, KANKER KHERA, MEERUT -250001,UP.Had applied for grant of recognition (UP-1504) for BTC. Course two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 104th meeting held on 15th - 17th July 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to appoint duly selected staff with the requisite qualification as per NCTE norms and standards and inform the Regional Committee. Accordingly letter of intent prior to recognition was issued to the institution on 26.07.2006. Further, vide letter dated 28.4.2008 the institution was asked to provide experience certificate of Principal as per NCTE Norms.

4. AND WHEREAS the applicant institution has not submitted reply despite lapses of stipulated period the matter was placed in NRC in its 141st meeting held on 22nd -24th May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- Experience certificate of Principal has not been submitted.

6. NOW THEREFORE grant of recognition Y.S.L. COLLEGE OF EDUCATION, SARDHANA ROAD, KANKER KHERA, , MEERUT -250001,UP. for the course in BTC is hereby refused.
