WHEREAS Sant Baba Bhag Singh Institute of Education, Educational Complex, Vill Khiala Padhiara Distt- Jalandhar, Punjab of recognition (PB-336) for M.ED course of One years (1) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constitute a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 109th Meeting held on 31st October to 01st November 2006, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution issued conditional recognition to the applicant institution on 11.06.2007 and clarification issued on 20.06.2007.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 142nd Meeting held on 14th June 16th June 2009 the committee decided that recognition to the said institution be refused for following reasons.

- Deficiencies communicated to the Institution in the Show cause notice has not been replied within stipulated period.

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to Sant Baba Bhag Singh Institute of Education, Educational Complex, Vill Khiala Padhiara District- Jalandhar, Punjab for the course in M.ED in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
