AND WHEREAS in its 138" Meeting held on 14th March to 16th March, 19 the Northern Regional Committee after considering the report of the visiting well as other relevant materials furnished by the applicant institution, was sfied that the applicant institution does not fulfill the requirements and issued a ce on 25.3.2009 to the applicant institution under provision to section 14(3) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant. tubion to make a written representation in this behalf. Accordingly Show Cause ce was sent to the institution on 25.03.2009 as under:-

The Government recommendation is negative. The land is not in the name of the Institution. CLU is not enclosed. Library facility is not as per NCTE Norms. Classroom size is less than the prescribed norms. Sufficient number of computers for 100 students is not there. No supporting documents (photo copy Stock registers) for the entry of equipments of different laboratories. There is no Language lab. .

AND WHEREAS the applicant institution has submitted representation to them Regional Committee, NCTE on 29.4.09. The matter was placed again ad in 142" meeting of NRC, which was held on 14" to 16" June, 2009, the inal file of the institution, and other related documents, Act of NCTE, 1993 ulations and Guidelines of NCTE published from time to time were considered he committee and the Committee observes that:
