ORDER

WHEREAS **Tika Ram Girls College, Sonapat, Mission Road, Sonapat-131001, Haryana** of recognition (**HR-249**) for **C.P.Ed.** course two years (2 yrs) duration under section **15(1)** of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2 AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3 AND WHEREAS in its **130th meeting held on 28th July – 31st July, 2008** the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and committee decided to issued a Conditional Recognition order and ask the institution (I) appoint duly selected staff with the requisite qualification as per NCTE norms and standards and inform the Regional Committee. Accordingly letter of intent prior to recognition was issued to the institution on 08.08.2008.

4 AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its **143rd meeting held on 127th – 29th June, 2009**. The original file of the institution along with all other related documents, affidavits, ACT of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time etc were considered and the committee decided that:-

- **The deficiency communicated to the institution still exists i.e. the appointed HOD does not have experience as per NCTE norms for C.P.Ed.**

5 AND WHEREAS the committee decides to refuse recognition and return FDRS if submitted.

6. NOW THEREFORE recognition to **Tika Ram Girls College, Sonapat, Mission Road, Sonapat-131001, Haryana**, for the course in **C.P.Ed.** is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
