- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 137th meeting held on 28th February 1st March 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 12.03.2009 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution had submitted any representation to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 141st meeting held on 22-24 May 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.
 - (a) CLU is not submitted.
 - (b) The built up area is not as per NCTE Norms.
- 5. NOW THEREFORE grant of recognition to COSMOS COLLEGE OF EDUCATION, K.NO. 173, VILLAGE MOHIYAPUR, PO SURAJPUR, NOIDA, G.B.NAGAR- for the course in M.Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
