ORDER

WHEREAS Lala Amichand Monga Memorial Education Trust, VPO – Ugala, Tehsil-Barara, Distt.-Ambala, Haryana has submitted application of recognition (HR-382) for B.Ed. course one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the visiting team had since submitted its report.

AND WHEREAS in its 107<sup>th</sup> meeting held on 26<sup>th</sup> – 27<sup>th</sup> August, 2006 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and committee decided to issued a Conditional Recognition order and ask the institution (i) appoint suitably selected staff with the requisite qualification as per NCTE norms and standards and (ii) inform the Regional Committee. Accordingly letter of intent prior to recognition was issued to the institution on 27.08.2006.

AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 143<sup>rd</sup> meeting held on 27<sup>th</sup> – 29<sup>th</sup> June, 2009. The original file of the institution along with all other related documents, affidavits, ACT, NCTE, 1993, Regulations and Guidelines of NCTE published from time to time etc were considered and the committee decided that:-

- As per affidavit submitted by the Institution, the Institution has taken affiliation from Kurukshetra University without the recognition by the NCTE.
- False affidavit regarding recognition of B.Ed. course by NCTE has been submitted.
- The College is being run without the recognition by NCTE.
- The Institution has contravened the NCTE Act.

AND WHEREAS the committee decides to refuse recognition and return FDRS submitted.

NOW THEREFORE recognition to Lala Amichand Monga Memorial Education Trust, VPO – Ugala, Tehsil-Barara, Distt.-Ambala, Haryana, for the B.Ed. Course is hereby refused.
