REFUSAL ORDER

176 JUL 2009

WHEREAS INSTITUTE OF PROFESSIONAL STUDIES, KH-3, KAVI NAGAR, GHAZIABAD-201002 had applied for grant of recognition (UP-2164) for B.ED. Additional intake one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 113 meeting held on 18-19 January 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution and committee decided to recognition be granted to the additional intake of 100 subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ affiliating University /body given effect before the commencement of the course . Accordingly conditional recognition was issued to the institution on 24.1.2007.

4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

4. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

5. NOW THEREFORE grant recognition to INSTITUTE OF PROFESSIONAL STUDIES, KH-3, KAVI NAGAR, GHAZIABAD-201002 for the course in B.ED additional intake is hereby refused.

5. If the Institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
