REFUSAL ORDER

WHEREAS RAJESH KUMAR MAHAVIDYALAYA, VILL & POST - KOHARESULTANPUR, JAUNPUR-222002, UP. had applied for grant of recognition (UP-2318) for B.Ed. Course one years(s) duration under section 14 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 123rd meeting held on 19th 22^{cd} November 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to Issue a letter of conditional recognition and ask the institution to Affidavit on Rs. 100/- stamp paper from the Management of The institution about the staff on the prescribed format. Accordingly letter of conditional recognition was Issued to the institution on 28.11.2007.
- 4. AND WHEREAS the applicant institution has submitted reply, dated 17.10.2008. The matter was placed in NRC in its 134⁶ meeting held on 20⁶ 22⁶ November 2008. The original file of the institution, along with all other related documents, affidavits, by the applicant institution decided a letter for University Nominees regarding Selection committee. And letter was issued to the institution on 1.12.2008.
- 5. AND WHEREAS the applicant institution has submitted reply. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
 - The University letter regarding nominee of the expert on the selection committee is not submitted.
- AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.
- NOW THEREFORE grant recognition to RAJESH KUMAR MAHAVIDYALAYA, VILL. & POST - KOHARESULTANPUR, JAUNPUR-222002, UP. for the course in B.P.ED course is hereby refused.
