## REFUSAL ORDER

WHEREAS MAULANA AZAD INSTITUTE OF HUMANITIES SC. & TECH., RAILWAY STATION ROAD, MAHMUDABAD, SITAPUR-261203,UP. had applied for grant of recognition (UP-2133) for B.P.Ed. Course one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institucion and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 131° (3° sitting) meeting held on 29° 31° August 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to appointment of faculty/staff by a duly constituted selection committee and ansure selection of candidates possessing qualifications as prescribed under rules. (A duly State Govt. /Affiliating Body Concerned whichever is applicable) along with an Affidavit on the prescribed format on Rs. 100/- stamp paper from the management of the institution and Affidavit of Rs. 10/- stamp paper from the staff appointed and staff list. Accordingly letter of conditional recognition was issued to the institution on 04.09.2008.
- 4. AND WHEREAS the applicant institution has submitted rapity. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.
- 5. NOW THEREFORE grant recognition to MAULANA AZAD INSTITUTE OF HUMANITIES SC. & TECH., RAILWAY STATION ROAD, MAHMUDABAB, SITAPUR-251203,UP, for the course in B.P.ED course is hereby refused.
