REFUSAL ORDER

WHEREAS VEER BAHADUR SINGH MAHILA MAHAVIDYALAYA, SANJAY GANDHI PURAM, FAIZABAD, ROAD, LUCKNOW, UP. Had applied for grant of recognition (UP-2111) for B.Ed. Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 112<sup>th</sup> meeting held on 27<sup>th</sup> and 28<sup>th</sup> December 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Government/Affiliation University/Body given effect before the commencement of the B.Ed. course Accordingly letter of intent prior to recognition was issued to the institution on 29.12.2006

4. AND WHEREAS the applicant institution has not submitted reply despite lapses of stipulated period the matter was placed in NRC in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> -24<sup>th</sup> May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.


6. NOW THEREFORE grant of recognition VEER BAHADUR SINGH MAHILA MAHAVIDYALAYA, SANJAY GANDHI PURAM, FAIZABAD, ROAD, LUCKNOW, UP. for the course in BTC is hereby refused.
