REFUSAL ORDER

17 JUL 2009

WHEREAS SURDEO PRASAD TRIPATHI MAHAVIDYALAYA, VILL & POST. BHATHAHIN KHURD, VIA-FAZIL NAGAR, KUSHINAGAR, UF. had applied for grant of recognition (UP-2392) for B.Ed. Additional intake one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 121²⁷ meeting held on 2²⁶ 9²¹ September 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to Affidavit on Rs. 100/- stamp paper from the Management of The Institution about the staff on the prescribed format, and Affidavit of Rs. 10/- stamp paper from the staff appointed and staff list. And with separate letter for painting of walls providing of black boards. Accordingly letter of conditional recognition was issued to the institution on 15.09,2007.
- 4. AND WHEREAS the applicant institution has submitted reply. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
 - · Affidavit on stamp paper of Rs. 100/- has not been submitted.
 - The details of appointed Principal and Faculty have not been submitted.
- AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.
- 6. NOW THEREFORE grant recognition to SUKDEO PRASAD TRIPATHI MAHAVIDYALAYA. VILL & POST. BHATHAHIN KHURD VIA-FAZI: NAGAR, KUSHINAGAR, UP. for the course in B.Ed. Additional Intake is hereby refused.
