**REFUSAL ORDER**

WHEREAS SHRI MADHAV COLLEGE OF EDUCATION AND TECHNOLOGY, KESHAV NAGAR , MODI NAGAR MARG, HAPUR, GHAZIABAD-245101 had applied for grant of recognition (UP-2415) for **M.ED. COURSE** one years(s) duration under section **15 (1)** of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 121 meeting held on 16-17 September 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution **decided to grant recognition under clause 7(11) of regulation 13.1.2006 and separate letter for clarification as to whether permission of competent authority has been obtained to run college in school building as the building is approved for school only. Accordingly conditional recognition was issued to the institution on 22.9.2007.**

4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- THE LIST OF APPOINTED FACULTY AS PER NCTE NORMS HAS NOT BEEN SUBMITTED TILL DATE.
- THE PERMISSION LETTER TO RUN COLLEGE IN THE SCHOOL BUILDING FROM COMPETENT AUTHORITY IS NOT SUBMITTED.

4. AND WHEREAS the **committee decides to refuse recognition and return FDRs if submitted.**

5. NOW THEREFORE grant recognition to SHRI MADHAV COLLEGE OF EDUCATION AND TECHNOLOGY, KESHAV NAGAR, MODI NAGAR MARG, HAPUR, GHAZIABAD-245101 for the course in M.ED. is hereby refused.

5. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
