REFUSAL ORDER

WHEREAS **Prabha Devi Mahavidyalaya, Khalilabad, Distt. Sant Kabir Nagar, U.P.** Had applied for grant of recognition (UP-2139) for BTC. Course two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 111th Meeting held on 30th November and 1st December 2006 at NCTE Hqrs. New Delhi, considered application of the institutions and after careful examination of relevant documents, Visiting Team Reports, Video Recording, Original file etc. found the institutions fit for grant recognition of the BTC. Course subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt. / Affiliation University/Body given effect before the commencement of the course. Accordingly letter of intent prior to recognition was issued to the institution on 02.12.2006

4. AND WHEREAS the applicant institution has not submitted reply despite lapses of stipulated period the matter was placed in NRC in its 141st meeting held on 22nd -24th May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

6. NOW THEREFORE grant of recognition **Prabha Devi Mahavidyalaya, Khalilabad, Distt. Sant Kabir Nagar, U.P.** for the course in BTC is hereby refused.
