REFUSAL ORDER

WHEREAS SARDAR PATEL SMARAK MAHAVIDVALAYA, VILL. + POST - LARPUR, AMBEDKAR NAGAR-224186, UP. Had applied for grant of recognition (UP-1826) for B.ED. Course one years(s) duration under section 14(1) of the NCTE Act. 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 109th meeting held on 31st October 1st November, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./Affiliating University given effect before the commencement of the B.Ed. course. Accordingly letter of intent prior to recognition was issued to the institution on 08.11.2006.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141st inceting held on 22nd -24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE, Published from time to time, etc. were considered and the committee observes that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- NOW THEREFORE grant of recognition SARDAR PATEL SMARAK MAHAVIDYALAYA, VILL. + POST - LARPUR, AMBEDKAR NAGAR-224186, UP. For the course in B.ED. In term of section 14(1) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
