WHEREAS Smt. GENDA DEVI MAHAVIDYALAYA, ALLIPUR BARWARA, POST. SIRAWALL, KASGANJ, ETAH-UP, had applied for grant of recognition (UP-3001) for M.ED. Course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 136<sup>th</sup> meeting held on 19<sup>th</sup> 21<sup>th</sup> January 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to (i) appointment of faculty / staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An Affidavit on the prescribed format on Rs 100/- stamp paper from the Management of the institution is required to be submitted. (ii) The institution shall make launch its own website covering, inter afia, the details of the physical infrastructure and other instructional facilities and the particulars of their proposed teaching and nor teaching staff etc. with photographs. The details of the website may be submitted. Accordingly letter of intent prior to recognition was issued to the institution on 23.01.2009.
- 4. AND WHEREAS the applicant institution has submitted roply dated. 16.02.2009. The matter was placed in NRC in its 137th meeting held on 28th February 1st March, 2009. The original file of the institution, along with all other related documents, affidavits and observed that the Institution is required to submit respect of selected Professor and Reader and attested copy of Ph.D degree in respect of all faculty members. Accordingly letter was issued to the institution on 12.03.2009.
- 5. AND WHEREAS the applicant institution has submitted reply dated. 13.05.2009. The matter was placed in NRC in its 141° meeting held on 22° 24° May, 2009. The original file of the institution, along with all other related documents, affidavits and observed that (i) The University letter regarding nomination of expert on the selection committee is not submitted. (ii) The selection committee was not constituted as per NCTE Norms. Accordingly letter was issued to the institution on 30.05,2009.
- 5. AND WHEREAS the applicant institution has submitted reply dated 16.06.2009. The matter was placed in NRC in its 143<sup>rd</sup> meeting held on 27<sup>th</sup> -29<sup>th</sup> June, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:
  - The University letter regarding University expert has not been submitted. Thus, the selection committee was not valid.

- NOW THEREFORE grant of recognition Smt. GENDA DEVI MAHAVIDYALAYA, ALLIPUR BARWARA, POST. SIRAWALI, KASGANJ, ETAH- UP. For the course in M.ED. In term of section 15(1) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
