WHEREAS Desh Bhagat Pandit Chetan Dev Govt. College of Education, Faridkot, Punjab of recognition (PB-216) for M.ED course of One Year (1) duration under section 13(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 10.12.2004.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visited team had since submitted its reports.

3. AND WHEREAS in its 120th Meeting held on 12th to 13th Aug 2007, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issue conditional recognition to the applicant institution on 28.05.2007 and notification issued on 28.05.2009.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 144th Meeting held on 12th June to 14th July 2009 the committee decided that recognition to the said institution is refused for following reasons.

The reply of the Institution has not been received in the stipulated time.

5. AND WHEREAS the committee decides to close file and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to Desh Bhagat Pandit Chetan Dev Govt. College of Education, Faridkot, Punjab for the course in M.ED in term of section 13(3)(b) of the NCTE Act, 1993 is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
