REFUSAL ORDER

WHEREAS LAL BAHADUR SHASHTRI SMARAK PG COLLEGE, PO- ANAND NAGAR, MAHARAJGANJ -273155, UP. had applied for grant of recognition (UP-2237) for B.ED. Course one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 117th meeting held on 26th 28th May 2007, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to appointment of qualified staff as per NCTE norms through properly constituted selection committee for issuance of Unconditional Recognition order. The conditions are following:
- (i) Advertisement Notice. (ii) Consolidated staff list on the prescribed format duly approved by the affiliating body. (iii) Proceedings of the selection Committee along with a copy of the letter from the affiliating body nominating a member for the selection committee. (iv) Individual Bio Data in respect of selected faculty. (v) Affidavit on Rs. 10/- stamp paper on the prescribed format. Accordingly letter of intent prior to recognition was issued to the institution on 11.06.2007.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141st meeting field on 22nd -24st may 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:
 - · The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- NOW THEREFORE grant of recognition LAL BAHADUR SHASHTRI SMARAK PG COLLEGE, PO- ANAND NAGAR, MAHARAJGANJ -273155, UP. For the course in BED. In term of section 14(1) of the NCTF. Act, 1993 is hereby refused.
