## REFUSAL ORDER

WHEREAS SHRI SAI COLLEGE OF EDUCATION AND TECHNOLOGY, B-74, TAKSHILA COLONY, GARH ROAD, MEERUT, U.P. had applied for grant of recognition (UP-2802) for B.ED. Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 141st meeting held on 22nd 24th May, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issued a letter under clause 7(9) of regulations 2007 subject to the submission of resolution of Jila Panchayat regarding approval of building plan. Accordingly letter was issued to the institution on 30.05.2009.
- AND WHEREAS the applicant institution has submitted reply dated 26:06,2009. The matter was placed in NRC in its 143rd meeting held on 27th -29th June, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - The date of birth mentioned in the bio data of Dr. G.S. Verma is 30 June 1949. while as per class X certificate the date of birth is 30 June 1945. Thus, false information was given.
  - Signature of University nominee, that is, Prof. Sureksha Pal on two minutes of the selection committee of the same date is different.
- AND WHEREAS the committee decided to refused recognition for B.Ed.course.
- NOW THEREFORE grant of recognition SHRI SAI COLLEGE OF EDUCATION AND TECHNOLOGY, B-74, TAKSHILA COLONY, GARH ROAD, MEERUT, U.P. For the course in B.ED is hereby refused.
