WHEREAS in terms of Section 14(1) of the NCTE Act. 1993 Deen Dayal College, Dwarikapuri, 4th Km. Stone, Bhopa Road, Shanti Nagar, Muzaffarnagar-251001, U.P. had submitted an application (code No. APN03114) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting M.P.Ed course of Two year duration with an annual intake of 30(Thirty) students 16.10.2006.

- AND WHEREAS vide order no F.NRC/NCTE/F-7/UP-2197/2007/65263/ dt. 15.11.2008
  the recognition was refused by NRC, NCTE Jaipur and against the order of refusal, the
  appellant institution preferred an appeal before the appealing authority i.e., National Counsel for
  teacher Education, New Delhi on 31.12.2008 under Section 18 of NCTE Act, 1993
- 3. AND WHEREAS on perusal of documents, memorandum of appeal, affidavit. VT Report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was no ground to accept the appeal and that it should be rejected. Accordingly, the appeal was rejected and the NRC,s order dated 05.11.2008 closing the file of the institution was confirmed.
- NOW, THEREFORE, the order dated No.F.NRC/NCTE/F-7/UP-2197/2007/65263 dt. 15.11.2008 hereby is confirmed.
