REFUSAL ORDER

WHEREAS GYAN MAHAVIDYALAYA, FACULTY OF EDUCATION, AGRA ROAD, ALIGARH-202001, UP, had applied for grant of recognition (UP-1454) for BTC. Course of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 104th meeting held on 15th 17th July, 2006. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issued letter of conditional recognition and ask the institution to (i) Appoint duly selected staff with the requisite qualification as per NCTE Norms and Standards and inform the Regional Committee. (ii) Submit an Affidavit on Rs. 100/- stamp paper as the affidavit submitted earlier was without the signature of the deponent. Accordingly letter of conditional recognition was issued to the institution on 26.07.2006.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141" meeting held on 22^{ml} -24th May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decided to refused recognition and return FDRs if submitted.
- NOW THEREFORE grant of recognition GYAN MAHAVIDYALAYA, FACULTY OF EDUCATION, AGRA ROAD, ALIGARH-202001, UP. for the course in BTC is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the douncil in terms of section 18 of NCTE Act, 1993.
