REFUSAL ORDER

24 JUL 2009

WHEREAS HLM COLLEGE, KI-114 KAVI NAGAR GHAZIABAD U.P. had applied for grant of recognition (UP-2682) for M.ED.Course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 136th meeting held on 19th - 21st January 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to (i) appointment of faculty / staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An Affidavit on the prescribed format on Rs 100/- stamp paper from the Management of the institution is required to be submitted. (ii) The institution shall make launch its own website covering, inter alia, the details of the physical infrastructure and other instructional facilities and the particulars of their proposed teaching and non - teaching staff etc. with photographs. The details of the website may be submitted. Accordingly letter of intent prior to recognition was issued to the institution on 23.01.2009.

4. AND WHEREAS the applicant institution has submitted reply dated 15.06.2009. The matter was placed in NRC in its 143rd meeting held on 27th -29th June, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- The Professor has not been selected through duly constituted selection committee as per NCTE norms for of selection committee dated 30 July 2008 is Mrs. Rani Sazni Verma but according to the University letter date 20 June 2008 the university nominee should have been Dr. Poonm Pandey. Thus the selection committee was not valid.

5. NOW THEREFORE grant of recognition **HLM COLLEGE, KL-114 KAVI NAGAR GHAZIABAD U.P.** For the course in M.Ed. In term of section 15(1) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
