REFUSAL ORDER

24 JUL 2009

WHEREAS VIDYARTHI SNATAK MAHAVIDYALAYA, JAGADISHPUR BARDIHA, POST. JAGADISHPUR DHARMDANI, , KUSHINAGAR, UP, had applied for grant of recognition (UP-2135) for M.ED. Course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 123rd meeting held on 19th 22rd November, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issued letter of intent prior to recognition and ask the institution to (i) appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. Along with an Affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution and Affidavit on Rs. 10/- stamp paper from the staff appointed and staff list. (ii) The institution concerned, after appointing the requisite faculty/staff, shall put the information on its official website and also formally inform the Regional Committee concerned. (iii) The University is requested to submit the required information along with documentary proof duly certified by the concern authority to Northern Regional Committee, NCTE for its approval. Accordingly letter of intent prior to recognition was issued to the institution on 29.11.2007.
- AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141st meeting held on 22std -24st May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- NOW THEREFORE grant of recognition VIDYARTHI SNATAK MAHAVIDYALAYA. JACADISHPUR BARDIHA, POST, JACADISHPUR DHARMDANI, , KUSHINAGAR, UP. For the course in M.ED. In term of section 15(1) of the NCTE Act, 1993 is hereby refused.

If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTF. Act, 1993.
