ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 C-Impact Institute, Seengana (Behind Gokulam Water Park, Post- Keetham, Tehsil- Kirawali, 20 KM Stone, National Highway-2, Kirawali, Agra, Uttar Pradesh had submitted an application (code No. APN04567) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed.(Add)course of One year duration with an annual intake of 100(One hundred) students on 4th July 2007.

2. AND WHEREAS vide order no F.NRC/NCTE/E-7/UP-2558/2008/03/10/08 the recognition was granted for the session of 2008-2009 by NRC, NCTE Jaipur and against the order of recognition, the appellant institution preferred an appeal before the appealing authority i.e., National Counsel for teacher Education, New Delhi on 26.12.2008 under Section 18 of NCTE Act, 1993 for grant of recognition from the session of 2007-2008

3. AND WHEREAS on perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was no ground to accept the appeal and that should be rejected. Accordingly, the appeal was rejected and the NRC's order dated 03.10.2008 granting recognition for B.Ed course with an additional intake of 100 from academic session 2008-09 was confirmed.

4. NOW, THEREFORE, the order No.F.NRC/NCTE/E-7/UP-2558/2008/64683-89 dt. 03.10.2008 is hereby confirmed.
