## FEFUSAL ORDER

WHEREAS LP. POST CRAPUATE COLLEGE, BULANDSHAHAR, BULANDSHAHR-203001, UP. had applied for grant of recognition (UP-1722) for M.ED. Course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 115<sup>th</sup> meeting held on 25<sup>th</sup> 26<sup>th</sup> March, 2007. The Northern Regional Committee after exasidering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and 25k the institution to appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Government/Affiliating University given effect before the commencement of the M.Ed. course. Accordingly letter of conditional recognition was issued to the institution on 02.04.2007.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> -24<sup>th</sup> May, 2009. The original file of the institution, along with all other related documents, affidavits. Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time; etc. were considered and the committee observed that:
  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- 5. AND WHEREAS the committee decided to refused recognition for M.Ed. course.
- NOW THEREFORE grant of recognition I.P. POST GRADUATE COLLEGE, BULANDSHAHAR, BULANDSHAHR-203001, UP. for the course in M.ED. is hereby refused.
