ORDER

WHEREAS **Maharaj Barhma Nand Bhuriwale Garib Dassi Rana Gajindr Chand Girls Elementary Teacher Training, Mansowal, Post-Binewal Garhsankar, Distt.- Hosiarpur, Punjab** of recognition (PB-453) for ETT course of Two years (2) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 27.12.2006.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 124<sup>th</sup> (II<sup>nd</sup> Sitting) Meeting held on 17<sup>th</sup> to 19<sup>th</sup> December 2007, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issued conditional recognition to the applicant institution on 30.01.2007 and clarification issued on 29.05.2009.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 144<sup>th</sup> Meeting held on 12<sup>th</sup> June 14<sup>th</sup> July 2009 the committee decided that recognition to the said institution is refused for following reasons.

- The reply of the Institution has not been received in the stipulated time.

5. AND WHEREAS the committee decides to refuse the recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to **Maharaj Barhma Nand Bhuriwale Garib Dassi Rana Gajindr Chand Girls Elementary Teacher Training, Mansowal, Post-Binewal Garhsankar, Distt.- Hosiarpur, Punjab** for the course in ETT in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing no. 524911 is returned herewith.

7. If the Institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
