## REFUSAL ORDER

WHEREAS SHRI M.S. CHAUHAN MAHAVIDVALVA, HARIDARSHAN NAGAR, MAIN PURI JUP. had applied for grant of recognition (UP-2746) for B.ED. Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 141<sup>st</sup> meeting held on 22<sup>nd</sup> 24<sup>th</sup> May, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to grant recognition 7(11) of Regulation 2007 subject to submission of approved building plan from competent authority. Accordingly letter was issued to the institution on 30.05,2009.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 145th meeting held on 26th -28th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - The building plan is only signed by Nagar Palika parishad but the letter of approval is not submitted.
- AND WHEREAS the committee decided to refused recognition for B.ED. Course and return FDRs.
- NOW THEREFORE grant of recognition SHRI M.S. CHAUHAN MAHAVIDYALYA,
  HARIDARSHAN NAGAR, MAIN PURI, U.P. for the course in B.ED. is hereby refused.
