#### REFUSAL ORDER

WHEREAS DHIRENDRA PAL SINGH INSTITUTE OF HIGHER EDUCATIONS, AGRA ROAD, MAINPURI, E.F. had applied for grant of recognition (UP-2837) for B.ED. Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to letter of intent prior to recognition and ask the institution to (i) appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution is required to be submitted. (ii) The institution shall make launch its own website covering, interalia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure, instructional facilities—and the particulars of their proposed teaching and non—teaching staff etc. Accordingly letter was issued to the institution on 23.01.2009.
- 4. AND WHEREAS the applicant institution has submitted reply dated 18.05.2009. The matter was placed in NRC in its 143<sup>rd</sup> meeting held on 27<sup>th</sup> -29<sup>th</sup> June, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - · Deficiencies pointed in the letter still exist.
- AND WHEREAS the committee decided to refused recognition for B.ED.
- NOW THEREFORE grant of recognition DIHRENDRA PAL SINGH INSTITUTE OF HIGHER EDUCATIONS, AGRA ROAD, MAINPURI, U.P. for the course in B.ED. is hereby refused.
