REFUSAL ORDER

WHEREAS MAHADEV INSTITUTE OF TECHNOLOGY, VILLAGE - RAMNAGAR, POST - AMINAGAR SARAI, DISTT. - BAGHPAT, U.P. had applied for grant of recognition (UP-2984) for **M.ED. COURSE** one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 138th meeting held on 14th - 16th March 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of Intent prior to Recognition and ask the institution to (i) appointment of faculty/ staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules along with an affidavit on Rs. 100/- stamp paper from the Management of the institution is required to be submitted. (ii) The institution shall launch its own Website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure and the particulars of their proposed teaching and non - teaching staff etc. with photographs. The details of the website may be submitted. Accordingly letter of Intent prior to recognition was issued to the institution on 24.03.2009.

4. AND WHEREAS the applicant institution has submitted reply. The matter was placed in NRC in its 139th meeting held on 10th -12th April, 2009. The original file of the institution, along with all other related documents, affidavits, materials furnished by the applicant institution decided to issue a letter and ask the institution to subject to submission of experience certificate as per NCTE norms in respect of appointed Professor Dr. Brij Bhusan and Reader Dr. Satish Kumar. Accordingly letter was issued to the institution on 02.05.2009.

5. AND WHEREAS the applicant institution has submitted reply dated 25.06.2009. The matter was placed in NRC in its 143rd meeting held on 27th -29th June 2009. The original file of the Institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- The selected Professor and Reader do not have experience as per NCTE norms for M.ED.

6. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.
