REFUSAL ORDER

WHEREAS SHRI GAURI SHANKAR SANSKRIT MAHAVIDYALAYA, SUJANGANJ, JAUNPUR, IIP, had applied for grant of recognition (IIP-2160) for B.ED. (Shiksha Sashtri) Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 116th (Second Sitting) meeting held on 07th 08th May, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a conditional letter of recognition and ask the institution to (i) appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Government/ Affiliating University given effect before the commencement of the M.Ed. course. (ii) Send a blue print of the building plan showing clearly demarcated area for B.ED. (Additional) M.ED. programmee. (iii) Advertisement notice. (iv) Consolidate staff list on the prescribed format duly approved by the affiliation body. (v) Proceedings of the Selection committee along with a copy of the letter form the affiliating body nomination a member for the selection. Accordingly letter of conditional recognition was issued to the institution on 26.05.2007.
- AND WHEREAS the applicant institution has submitted reply. The matter was placed in NRC in its 141" meeting held on 22" -24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decided to refused recognition for B.ED. (Shikha Sashtri) course.
- NOW THEREFORE grant of recognition SHRI GAURI SHANKAR SANSKRIT MAHAVIDYALAYA, SUJANGANJ, JAUNPUR, UP. for the course in B.ED. (Shiksha Sashtri.) is hereby refused.
