- 4 AND WHEREAS the applicant Institution has submitted representation to Northern Regional Committee, NCTE on 30.03.2009. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 139th meeting held on 10th -12th April 2009 the committee decided that recognition to the said institution be refused for the following reasons.
 - CLU is not issued by the competent authority on the prescribed format.
 - In response to our letter, the state Govt. recommendation is negative.
