#### REFUSAL ORDER

1 8 AUG 2009

WHEREAS Kishan Institute of Teacher Education, Mewla Crossing, Near Amar Ujala , Delhi Road, Partapur, Meerut, U.P. had applied for grant of recognition (UP-2400) for M.ED. Course of one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 119th meeting (2nd sitting) held on 04th 05th August, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to (i) appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, along with an affidavit on the prescribed format on Rs. 100/- stamp paper from the management of the institution and affidavit on Rs. 10/- stamp paper from the staff appointed and staff list. (ii) the institution concerned, after appointing the requisite faculty/staff, shall put the information on its official website and also formally inform the regional committee concerned. Accordingly letter of intent prior to recognition was issued to the institution on 13.08.2007.
- AND WHEREAS the applicant institution has submitted several replies and the matter finally placed in NRC in its 142nd meeting held on 14th -16th June, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:
  - One Professor and one Reader have not been appointed at all.
  - Affidavit in Proper format on Rs. 100/- stamp paper has not been submitted.
- AND WHEREAS the committee decided to refused recognition for M.ED. course.
- NOW THEREFORE grant of recognition Kishan Institute of Teacher Education, Mewla Crossing, Near Amar Ujala, Delhi Road, Partapur, Meerut, U.P. for the course in M.ED is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
