## ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Shree Ganpati Institute of Education & Technology, VIII-Faizabad, Post-Hudina, Tehs-Narnaul, Disti-Mohindergarh, Haryana, has submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed Course of One year duration with an annual intake of 100 ( Hundred only) students on 17.12.2007.

- 2. AND WHEREAS the matter was placed in 139<sup>th</sup> Meeting held on 10<sup>th</sup> -12<sup>th</sup> April 2009. The committee after considering the application and reply submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, was satisfied that the applicant institution does not full fill the requirements and has decided to refuse recognition of the institution. Accordingly, Refusal order was issued vide order No. F.NRC/NCTE/F73/HR-1259/2009 dated 23.04.2009.
- 3. AND WHEREAS the institution has preferred an appeal on 09.06,2009 against the refusal order of NRC dated 23.04.2009 to the appellate authority. The appeal of the institutions was accepted and NRC's order dated 23.04.2009 was set aside by the appellate authority with direction to the NRC to grant recognition to the institution immediately vide order dated 07.08.2009.
- 4. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Shree Ganpati Institute of Education & Technology, Vill-Faizabad, Post-Hudina, Tehs-Narnaul, Distt-Mohindergarh, Haryana, for conducting B.Ed of Secondary (Level) of One year duration with an annual intake of 100 (Hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
