WHEREAS In terms of Section 15(1) of the NCTE Act, 1993 VB TEACHER TRAININIG AND RESEARCH, JIND BYE PASS, TOWARD HISAR ROAD, TEH.DISTT-ROHTAK, Haryana, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting D.Ed Course of Two years duration with an annual intake of 50 (Fifty only) students on 02.01.2008 and NRC granted recognition/permission to the institution for conducting D.Ed. Course of two years duration with an intake of 50 students from the academic session 2008-2009 under clause 7(11) of NCTE Regulations, 2007 vide Order No. F.NRC/NCTE/HR-1368/2008/57175-81 dated 19.8.2008.

- 2. AND WHEREAS a complaint was received on 16.10.2009 which was placed in NRC in its 136th meeting held on 19-21st January 2009 wherein the Committee had decided to call details of staff (Teaching and non teaching) alongwith salary statement for the last one year under Section 17 of the NCTE Act 1993.
- AND WHEREAS the applicant institution had submitted representation to Northern Regional Committee, NCTE on 2.3.2009. The matter was placed in its 141st meeting hold on 25-26th May 2009, the original file of the institution, VTR, reply received from the institution alongwith all other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time were considered by the Committee and decided to withdraw the recognition. Accordingly, Withdrawal order was issued vide order No. F.NRC/NCTE/F-7-3/HR-1368/2009/3652-58 dated 03.06.2009.
- AND WHEREAS the institution has preferred an appeal on 09.06.2009 against the withdrawal 4. order of NRC dated 03.06.2009 to the appellate authority. The appeal of the institutions was accepted and NRC's order dated 09.06.2009 was set aside by the appellate authority with direction to the NRC to grant recognition to the institution immediately vide order dated 07.08.2009.
- NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to VB TEACHER TRAININIG AND RESEARCH, JIND BYE PASS, TOWARD HISAR ROAD, TEH.& DISTT-ROHTAK, Haryana, for conducting D.Ed of Elementary (Level) of Two years duration with an annual intake of 50 (Fifty only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NOTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC. the State Government etc, wherever applicable.
