

#### REFUSAL ORDER

WHEREAS Ram Murti Devi girls College, Khasra No.-506, Vill.-Shakoorpur, Post-Mohiuddinpur, Distt.-Ghaziabad, UP. had applied for grant of recognition (UP-2954) for B.FD. Course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 139<sup>th</sup> meeting held on 10<sup>th</sup> 12<sup>th</sup> April, 2009. The Northern-Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent to recognition and ask the institution to Provide appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An affidavit on the prescribed format on Rs. 100/- stamp paper from the management of the institution is required to be submitted. The institution shall launch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure and other instructional facilities and the particulars of their proposed teaching and non—teaching staff etc. Accordingly letter of intent prior to recognition was issued to the institution on 02.05.2009.
- 4. AND WHEREAS the applicant institution has submitted reply date 02.06.2009. The matter was placed in its 142<sup>nd</sup> meeting held on 14<sup>th</sup> 16<sup>th</sup> June. 2009. The original file of the institution, along with all other related documents, affidavits by the applicant institution decided to issue a letter and ask the institution to provide the selected principal is not qualified. Accordingly letter was issued on 25.06.2009.
- 5. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 145<sup>th</sup> meeting held on 26<sup>th</sup> 28<sup>th</sup> July, 2009. The original file of the institution, along with all other related documents, affidavits. Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - . The reply of the institution has not been received in the stipulated time.
- 5. AND WHEREAS the committee decided to refused recognition for B.ED.Course.
- NOW THEREFORE grant of recognition Ram Murti Devi Girls College, Khasra No.-506, Vill.-Shakoorpur, Post-Mohiuddinpur, Distt.-Ghaziabad, UP. for the course in B.ED. course is hereby refused.
