WHEREAS SANT RAM KRISHNA KANYA MAHAVIDVALAYA, SHIVPURI, BALKESHWAR ROAD, AGRA-282004, UP. had applied for grant of recognition (UP-2493) for BTC Course of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 128th meeting held on 09th 10th April, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issued a letter of intent prior to recognition and ask the institution to (i) appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules along with an affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution and Affidavit on Rs. 10/- stamp paper from the staff appointed and staff list. (ii) the institution concerned after appointing the requisite faculty/staff, shall put the information on its official website and also formally inform the Regional Committee concerned. Accordingly letter of intent prior to recognition was issued to the institution on 22.04.2008.
- 4. AND WHEREAS the applicant institution has submitted reply dated 18.05.2009. The matter was placed in NRC in its 142rd meeting held on 14th 16th June, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issued clarification and ask the institution to the appointed principal is not qualified as per NCTE norms for D.Ed. Accordingly letter was issued to the institution on 22.06.2009.
- 5. AND WHEREAS the applicant institution has submitted reply dated 26.06,2009. The matter was placed in NRC in its 145th meeting held on 26th 28th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The affidavit on Rs. 10/- stamp paper by Principal is false as his date of birth is wrongly mentioned.
- AND WHEREAS the committee decided to refused recognition of BTC course and return FDRs.
