REFUSAL ORDER

WHEREAS SHAID CAPTAIN VIJAY PRATAP SINGH MAHAVIDHYALAYA, AWAZAPUR, TEHSIL- SAKALDIHA, CHANDAULI, U.P. had applied for grant of recognition (UP - 2861) for B.ED. Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 140th meeting held on 25th 26th April, 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25.06.2009 to the applicant institution under proviso to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
 - 4. AND WHEREAS the applicant institution had submitted representation. The representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 144th Meeting held on $12^{th}-14^{th}$ July, 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.
 - (a) The deficiencies communicated to the institution still exist.
 - 5. NOW THEREFORE grant of recognition to SHAID CAPTAIN VIJAY PRATAP SINGH MAHAVIDHYALAYA, AWAZAPUR, TEHSIL- SAKALDIHA, CHANDAULI, U.P. for the course in B.ED. course in term of section 14(3) (b) of the NCTE Act, 1993 is hereby refused.
